Matei Negrescu is an executive in the energy industry, currently working as the Head of Area Development for North Sea Renewable Energy activities at Equinor, an international energy company developing oil, gas, wind and solar energy in more than 30 countries worldwide. Matei joined Equinor in 2006 after graduating with a Master of Science in Petroleum Engineering from Imperial College London. He has extensive leadership experience across energy value chains – from oil & gas to renewables, and from strategy to project development – and across geographies – from the North Sea to Brazil, Algeria and China. Matei is bi-cultural, born in Romania and grown up in France. He has lived, studied & worked in 8 countries, speak 8 languages.



Colin Tan is the Director of Operations for TusPark Newcastle, the first international TusPark fully-owned by TUS Holdings, China's largest innovation ecosystem of over 300 bases in every major city in China. He works with TUS's partners in the UK to help businesses, universities and governments to enter and scale-up in the Chinese market. He is also an entrepreneur, technology investor, and has helped to build tech ecosystems in the North of England as part of the Northern Powerhouse project.

Colin is also an early-stage investor and entrepreneur.

As one of the first tech startups in the North of England, his company Rentlord became an investee of Seedcamp and 500 Startups, and was the first UK company on the Techcrunch Disrupt stage. He also helped create Dotforge Impact, the first accelerator in the North of England funded by the Cabinet Office to help tech entrepreneurs create social impact businesses.

Colin is an active mentor and community builder for the UK tech ecosystem. He established and ran the first UK-China accelerator, FORGE, and regularly shares his insights with early-stage startup entrepreneurs.

Originally from Singapore, he is also a published poet and was active in the literary scene early in his life. He remains passionate about social causes, especially education, and had worked in the non-profit sector at the United Nations in Geneva.

He is a Fellow of the Royal Society of the Arts.

John McLean is a Non-Executive Chairman and Director who has extensive public and capital market experience with a specific knowledge of China where he has worked for over 22 years. In 2017 John chaired a report on corporate governance between China and the UK for the British Embassy in Beijing and The Foreign and Commonwealth Office. John works closely with the City of London and for 2019 was the Lord Mayor's envoy to China and led the Fintech business delegation to China in March 2019. In 2021 he was appointed Chair for the Institute of Directors for the City of London.

John was on the board of CBBC (China Britain Business Council) for 8 years until 2019 and more recently he was appointed the Senior Advisor to CCCUK (China Chamber of Commerce in the UK) to continue to contribute to the promotion of UK/China trade.

In 2007 John joined the board of Humberts plc (now Chesterton), the estate agent, and became its Executive Chairman to lead its rescue and ultimate disposal. Prior to this, he carried out a strategic review for Gamma Holdings NV of their UK textile, wallpaper, retail and brand companies, including Sanderson and William Morris, and as the CEO he successfully implemented the turnaround and disposal plan. Along with operations in Australasia, America and Canada, Sanderson established global trading partnerships in China, which included the setting-up of a manufacturing joint venture, brand licensing agreements and numerous retail franchises.

In the nineties, John was Finance Director and then CEO of ICS, the UK logistics business and co-led a management buy-out of the company with 3i, prior to its successful disposal to Hays plc. In the eighties, John was Finance Director of Gresham House plc, a listed Investment Trust which held investments in Europe and America. Prior to that, John trained

as a Chartered Accountant and was previously with Coopers & Lybrand (now PwC) in both London and New York.

In addition to these roles, John was a member of the Council of the international charity, VSO (Voluntary Services Overseas) and was chairman of VSO China for 5 years from 2010. More recently in 2018, John became Chair of the leading UK national charity, Carers Trust which works to improve support, services and recognition for anyone living with the challenges of caring, unpaid for a family member or friend. Additionally, he is Chair of The Princess Royal Respite Fund for Carers.

Since 2016, he has sat on the Lord Mayor's Charity Appeal Board and heads up their China relations, including the UK-China Charity Initiative.

In the 2014 New Year's Honours list, John was honoured with an OBE for services to British business interests and the development of civil society in China.

During the uni, she did internships in KPMG, Zurich Insurance and FTI Consulting.




